

Standing Up for Joseph Gomm, Safe Staffing

Following the death of CO Joseph Gomm, the AFSCME Council 5 Correctional Policy Committee released this statement Friday:

We and our 2,000 correctional brothers and sisters from across Minnesota have spent the

past week and a half mourning the loss of our fallen brother, correctional officer Joseph Gomm.

We send our condolences to his mother, brothers and sisters, nieces and nephews, and friends.

We will hold Joe and his wicked sense of humor, his great sense of integrity and his commitment to our mission close in our hearts. We want to thank all of the correctional workers, other law enforcement officers and the communities who helped us through this past week. We greatly appreciate the outpouring of love and support for Joe and our correctional family.

We will not let Joseph Gomm die in vain. We want to ensure that every person who works in corrections can come home safely, and that we can keep our institutions and communities safe.

Although the Department of Corrections has communicated during this time of mourning, they have not communicated with us about the safety measures presented Friday nor given us an opportunity to work with them to find solutions.

We have several policy issues that we will be demanding get resolved. We have dangerously low numbers of correctional officers, levels that are far worse than the statistics reported by DOC Friday. This is unacceptable.

Officers are not given all the equipment they need to safely do their jobs, and that also must be addressed.

After years of asking legislators for enough funding to do our jobs safely, we are demanding bipartisan support, communication and collaboration from the department and all levels of state government to provide us with the adequate level of correctional officers, tools, resources and policies we need to do our job and to keep our institutions and the public safe.



I also enjoyed being able to reflect on and share my personal short and long term goals within my union.

The biggest thing that I learned is that although we all come from different lines of work, states, and backgrounds we can all take our experiences and find ways to work together. We all have a goal of making the labor movement a success. Our differences are our biggest asset.

I had a great experience at the Midwest school and got to meet many amazing people. With classes covering diversity, immigration, and other current issues it was really informative, especially with working in the Human Services field. My favorite part would have to be the bus ride around the city and the guest speakers we had, also participating in the rally to raise the minimum wage was eye opening and a great experience.





I attended the School for Women Workers hosted by the Labor Education Service University of Minnesota Twin Cities from June 24-28, 2018. I took advantage for the track class "Your Rights in the Workplace." In these classes we learned about the Weingarten Rights. Worker's "Weingarten Rights", provide the employee union representation for any meeting with a supervisor. The employee only needs to request representation.

We also learned that most union contracts contain language that management needs "just cause" to discipline an employee. The burden of proof is on management that they had just cause for disciplinary action. Most arbitration defines "just cause" based on seven criteria.

Was the employee aware of the rule?
Was the employer's rule reasonable?
Was there an investigation?
Was the investigation fair?
Did they find proof of guilt?
How was this rule, investigation applied to other employees?

Did the punishment fit the crime?

The union's role is to demonstrate that the employer lacked just cause. The training I received at Midwest Women Worker's Conference was very helpful to me as a new steward. I highly recommend this conference and training.

The information we covered will all be incorporated in the upcoming Stewards Trainings for our Local and I have already begun applying my new knowledge in meetings with members and management alike.

AFSCME's 43rd International Convention was held in Boston the week of July 16—20, 2018. Local 34 sent 7 delegates: Grace Baltich, Jean Diederich, Kenneth W. Garnier, Tamika Hannah, Paul Madison, Sheri Peterson & David Yang and 7alternates: Yunuen Avila, Sametta Hill, Nailah Holman, Remy Huerta-Stemper, Abby Korenchen, Andrea Lazo-Rice & Lindsay Schwab. Nailah Holman was upgraded to delegate status when Sheri Peterson had to leave.

Our delegation participated in all aspects of the convention –attending classes at 7:30AM each morning; sitting on the convention floor or in the alternate/guest section listening to speeches by Elizabeth Warren, AFT President

Randi Weingarten, SEIU President Mary Kay Henry, NEA Secretary-Treasurer Princess Moss, Boston Mayor Marty Walsh, New Jersey Governor Phil Murphy as well as presentations on PEOPLE Power, external and internal organizing, standing up to fight anti-union operatives with their lies about right-to-work and Memphis sanitation workers, President Lee Saunders and Secretary-Treasurer Elissa McBride; getting up early on Thursday to vote for our Secretary-Treasurer - Elissa McBride won with an overwhelming vote - and vote on the amendments to our International Constitution and resolu-

Signed into law by President Franklin D. Roosevelt 83 years ago today, the National Labor Relations Act marked a critical step forward for working people's right to join together in unions and bargain collectively.

As Roosevelt said at the time, "By preventing practices which tend to destroy the independence of labor, it seeks, for every worker with its scope, that freedom of choice and action which is justly his."

218%: Rise in union density 10 years after passage of the NLRA.

From the July 10,2018 Labor Wire:

Working people are already grappling with a brand of corporate, right-wing judicial activism that has taken hold of whole swaths of the justice system. In her dissent in Janus v. AFSCME, Council 31, **Justice Elena Kagan** warned against those who would act as a "black-robed ruler overriding citizens' choices."

Judge Kavanaugh has made it clear he would be more of the same. He has spent his career ruling against working families, undermining our rights at work and enabling discrimination on the job:

American Federation of Government Employees, AFL□CIO v. Gates: Handed down an opinion that his colleagues argued would allow the secretary of defense to "abolish collective bargaining altogether."

Agri Processor Co. Inc. v. National Labor Relations Board: In a dissent, wrote that a company should not be ordered to bargain with a union, arguing that undocumented workers were ineligible to vote in a union election (in direct conflict with long-standing Supreme Court precedent).

SeaWorld of Florida LLC v. Perez: Dissented from a majority opinion upholding a safety citation against SeaWorld following the death of a trainer.

Venetian Casino Resort LLC v. NLRB: Overturned an NLRB decision finding that a hotel engaged in unfair labor practices when it requested police officers issue criminal citations to union demonstrators who were legally protesting.
